

# Mescalero Apache Tribal Gaming Commission (MATGC)

Application for Class III Gaming License

All applicants applying for employment in a gaming position at the Inn of the Mountain Gods Resort Enterprise must apply for a Gaming License from the Mescalero Apache Tribal Gaming Commission (MATGC).

- ♦ The attached eight (8) page application must be filled out completely and returned to the MATGC office. If a question does not apply to you, please state so with the acronym "N/A", or insert the words "not applicable" (Attach additional sheets if necessary).
- ♦ The Authorization for Release of Information must <u>NOT</u> be signed until applicant is in the presence of a Notary Public.
- ♦ Applicant must bring two (2) valid forms of identification with application. One (1) of the forms must be a valid picture identification. The following will be accepted (A birth certificate is <u>not</u> an acceptable form of identification):
  - \* State Issued Drivers License
- \* State Issued ID
- \* Tribal ID

- \* Social Security card
- \* Passport
- \* Resident Alien Card
- \* School ID (must have an expiration date)
- \*Voters Registration Card
- \* Certificate of Indian Blood (CIB)

#### PRIVACY ACT NOTICE

Failure to consent to the disclosures indicated in this notice will result in a tribe's being unable to license you for a primary management official or key employee position. The disclosure of your Social Security Number (SSN) is voluntary. However, failure to supply a SSN may result in errors in processing your application.

A false statement on any part of your application may be grounds for denying a license or the suspension or revocation of a license. Also, you may be punished by fine or imprisonment (US Code, title 18, section 1001).

Copies of court documents must be provided. Failure to comply may result in the suspension or possible revocation of your Gaming License.

You must LIST all charges on the previous page, which have occurred since the age of 18, even if charges were dismissed, deferred, dropped, pending or expunged. Explain each charge fully and attach additional sheets if necessary. False or incomplete information may result in denial or revocation of your Gaming License.

All Inn of the Mountain Gods Resort & Casino, Casino Apache and Elk Lodge Casino key employees shall renew their Gaming License 60 days prior to the expiration date. Failure to renew shall result in a fee for reprocessing.
